I have been to the site with Council's Heritage Adviser, Shona Lindsay, and appreciate the station has some heritage values.

We note that pumping station number 47 in Rose Bay is already listed.

We request that if the station does get listed on the LEP, that the **number (46)** is included in the naming of the station to prevent confusion.

If the SPS 46 / WWPS46 / Waste Water Pumping Station Number 46 is listed on the LEP, Sydney Water requires =

- 1. Full access to maintain the station.
- 2. Council is aware that upgrades of the equipment housed in the building will be made when deemed necessary. This includes pumps, valves, motors, lighting, telemetry, ventilation systems and more.
- 3. That Council notes that the interior stairs, ladders and railings are old and are unlikely to comply with current safety standards, and that these will need to be replaced at some stage.
